Municipal Recycling Drop-Off Sites

If you are a regular reader of our newsletter, you know that we are always trying to promote the types of items which can and cannot be placed in the recycling drop-off containers located throughout Clinton County. To continue with our educational efforts, we would like to remind residents that recyclables need to be placed in the appropriate containers and sorted by material. Please do not place bags of recyclables in or next to the containers. We ask that if there is not room in the recycling container, that you call us so we can empty the container or take your material to a different location. Although this may be inconvenient we always try to keep our sites neat and tidy and we cannot do this if there are bags and cardboard lying around.

Most sites now offer office paper, junk mail, magazines and paperboard recycling. Please refer to the list on the back page of this newsletter for locations and the materials accepted at each site. Please contact us if you have questions regarding what can or cannot be recycled.



Who Knew Waste Was So Valuable?

The municipal waste collection, recycling and disposal industry in Pennsylvania contributes more than \$4.2 billion a year to the state's economy and supports more than 26,000 jobs, according to research from Philadelphia consulting firm Econsult Solutions Inc. The report, commissioned by the Pennsylvania Waste Industries Association, is based on accepted economic methodology, using official state and national data and information collected in a survey of Pennsylvania landfill operators, haulers and recyclers, according to a news release. The municipal waste industry collects, hauls and disposes of 8.6 million tons of Pennsylvania municipal solid waste annually. The amount of materials recycled in Pennsylvania grew 20 percent, from 4.8 million tons in 2006 to 5.85 million tons in 2011, according to the release.

About 30 percent of Pennsylvania's recycled commodities are exported, which brings new money into the state economy. "Along with that, we have also evolved into the 'front end' of recycling in Pennsylvania," said PWIA President Mark Pedersen, who also is general manager for Republic Services Inc.'s York office. "Our members collect, haul, separate and process recyclables that become the feedstock for reuse and remanufacture into new products. Recycling has become the fastest-growing component of our industry."

Pennsylvania has more than 2,200 places that collect and process recyclables, about 500 manufacturers that use recycled materials, and another thousand enterprises involved in reuse and remanufacturing, according to the news release. About half of the trash industry's economic impact comes from direct annual operating expenditures and employment within the municipal waste industry — roughly \$2.3 billion, according to the release. The industry directly provides jobs to about 12,000 people at an average wage of \$55,000 per year.

Curbside Recycling Application

Have you considered the convenience of curbside recycling? The Authority will stop by your home every two (2) weeks and pick up your recyclables for a nominal annual fee of \$30 (\$2.50 per month). The materials we collect include: aluminum & tin cans, clear/brown/green glass bottles & jars, newspaper, magazines, junk mail, paperboard and plastic containers (< 1 gallon in size). (The Authority is under contract with the City of Lock Haven to provide this service to city residents. If you live in the City, please continue to put your recyclables out on your curbside on the regularly scheduled dates. If you need a collection box, call City Hall at 570-893-5900.)

Landfill News/Updates

After 5 Years of planning, the WTL's new Administration/Education/Employee facility is now complete. We officially moved in on May 19th.

The WTL rail yard is complete and ready for business. This will provide the WTL and area businesses with rail opportunities that never existed before in Wayne Township.

The WTL Compressed Natural Gas (CNG) fueling station, located at the end of Fritz Road, is open to the public 24/7. Our station accepts most major credit cards. Please feel free to contact us about usage of this station.

The 75 acre Northside Landfill redevelopment is underway. We have completed construction of Cell 1, which is approximately 12 acres in size and we are currently in the process of getting Cell 2 ready for liner system construction this coming August. This will add another 10 acres of developed disposal capacity to the Northside Landfill.



Clinton County Residential Tire Collection Event

On Friday, May 16th from 8:00 am to 4:00 pm and Saturday, May 17th from 8:00 am to 12:00 noon, the Authority held another Tire Collection Event. We extended an invitation to 10 neighboring townships from Lycoming County to participate. The event was very successful. Residents from 25 of 29 Clinton County municipalities participated and more than 280 vehicles participated. The event collected 3,709 tires, bringing the total number of tires collected since 2003 to over 62,000 tires!



Commercial/Industrial Recycling in Clinton County

Do you have a **commercial or industrial** establishment located in Clinton County? If so, then you are eligible to participate in our Commercial Recycling Program. The Authority has a flexible and cost effective recycling program to meet the needs of every establishment. We currently offer three commercial recycling options:

- 68 gallon wheeled carts, serviced weekly - \$120.00 per year or \$10.00/month.
- 68 gallon wheeled carts, serviced bi-weekly - \$60.00 per year or \$5.00/month.
- Blue Box, serviced bi-weekly - \$30.00 per year or \$2.50/month.

Our commercial recycling carts are labeled for your convenience, covered and have wheels to make them easy move when full. If you need assistance in determining what your recycling needs are please feel free to give us a call.

- ◆ CNG (Compressed Natural Gas) Facility is open for business (24/7), please call if you have questions.
 - ◆ Please visit the WTL's new web site for updated information on recycling, the landfill and other events.
 - ◆ As of January 2013 it is illegal to put televisions, computers, and any of their components in the garbage. These items can be recycled free of charge at our recycling center in Wayne Township.
 - ◆ Educational Tours for all ages are available by appointment, please call us to schedule an appointment.
 - ◆ Clinton County residents with appliances containing Freon can bring these to the WTL free of charge.
 - ◆ The Authority is currently accepting letters of interest from non profit organizations to be chose as beneficiary for the 2014 WTL John B Hoy, Jr. Memorial Charity Golf Tournament. Letters must be received by 4:00 pm, June 20, 2014.
 - ◆ Brush & Yard Waste can be brought to our mulch facility free of charge. Then on your way out purchase a load of landscape mulch. Regular Double Ground is \$19.00 per yard and the colored (red, brown and black) is \$25.00 per yard.
