#### **Curbside Recycling**

Have you considered the convenience of curbside recycling? The Solid Waste Authority will stop by your home every two (2) weeks and pick up your recyclables for a nominal fee of \$30 per year, which works out to \$2.50 per month. Recycling should help to reduce your garbage bills and minimize those trips to the county recycling drop-off sites. We currently have curbside collection programs in Flemington, Mill Hall, Avis, Woolrich, Dunnstown, Castanea, McElhattan, Beech Creek and Renovo Areas.

**Please Note:** The Authority is under contract with the City of Lock Haven to provide this service to city residents Free of Charge. If you live in the City, please continue to put your recyclables out on your curbside on the regularly scheduled dates.

When you subscribe to this convenient service you will be given a "blue box" to place your recyclables in. You will also be given information on the materials we collect and directions on how to prepare the materials for recycling. The materials we collect include: aluminum & tin cans, clear/brown/green glass bottles & jars, newspaper, magazines, junk mail, and No. 1 & No. 2 plastic bottles.

All of the materials can be placed in the blue box as noted in the directions. It is that simple!!! Please feel free to call us with any questions you may have.

### **Electronics Recycling Has Arrived**

On September 7th, 2004 the Authority began accepting electronics at its Recycling Center in McElhattan free of charge. Electronics are considered to be any of the following items: televisions, computers and all accessories, printers, monitors, scanners, CD players, VCR's, stereo's, PDA's, telephones, answering machines, fax machines, camcorders and DVD players. We do not accept microwave ovens. The Recycling Center is accepting the above mentioned items on a daily basis, during regular business hours.

If you are asking yourself why you should recycle a computer or any of the items listed above, the answer is because they may contain hazardous materials such as mercury, cadmium, and lead. Electronics make up 40% of all lead and 70% of heavy metals found in landfills. If electronic items are not disposed of properly these toxins can be released into the environment.

In an effort to remain environmentally friendly, it is the

## Message from the General Manager

This year has brought about several challenges for the Authority and its staff. Most of these have been tackled in stride, but others have taken time and effort to get behind us. With two of the wettest years back to back in over 100 years, one of these challenges relates to the operational hardships caused by the uncharacteristic amount of precipitation. The wet weather has hampered the staff that must work rain or shine and has also sent the costs of operating the landfill through the roof due to the extraordinary efforts to deal with unrelenting wet conditions.

Odor is another huge challenge to the waste industry. The Wayne Township Landfill continues to put every effort and resource available towards controlling this issue. The latest effort has been the installation of an odor curtain along State Route 220. You may have noticed a fog like material when passing by the landfill; this is an odor neutralizer with a masking agent. We also continue to monitor and regulate vacuum on each of the landfill gas collection system wells twice a week. This effort ensures for optimum gas collection efficiency.

Safety is the biggest focus for Authority employees and customers. We are asking for you to assist us with this task. Flease drive slow when you approach our trucks picking up recyclables along the road. We also ask that you use the same caution with those trucks picking up your household garbage. Flease slow down and help make sure that we all get home to our families safely.

This year we held a county-wide residential tire collection event again, with great success. This year's event collected over 3500 tires from all over the county. We have collected over 12,000 tires since we started these events. I would also like to remind everyone that the landfill accepts tires on a daily basis from Clinton County residents for very nominal charge.

The new year is coming and we would like to make sure all County residents are aware of our Curbside Recycling Program. It is time once again to sign up for 2005. Please watch for your renewal in the mail. If you have not previously participated in this program, our curbside recycling program offers curbside pick up of your recyclables twice a month. Please watch for the sign up form in all of the local newspapers. The cost is only \$30 per year, which equates to \$2.50 per month.

The challenges of 2004 have made us all stronger and better prepared for what the future holds. As always we want to be the best we can be and will make every effort to make sure your experience with us is pleasant and efficient. Please feel free to contact us with questions or concerns.

#### Christmas is coming and...

- Another idea is to use old Christmas cards, cut out the pictures and punch a small hole in the top and add ribbon.
- Make Santa's Elf by cutting out a single egg carton compartment, decorate with magic marker, add cotton for the hair and beard.
- Make icicles from aluminum beverage cans by cutting the can into strips and then curling them around a pencil.
- Christmas fans are made by folding old greeting cards and taping the end with clear tape, then add a ribbon and hang.

# **Wayne Township Landfill Facts:**

- Over 1 Billion cubic feet of landfill gas has been delivered to the Jersey Shore Steel Company since July 1999. As a result, the steel company has been able to conserve approximately 600,000 million BTUs of natural gas.
- Clinton County residents and businesses recycled over 9,000 tons of material in 2003. This equates to over 4 months of saved disposal capacity when compared to the average monthly County waste disposal rate.

- **Mulch** The Wayne Township Landfill continues to sell landscape mulch. Wayne Township Residents are allowed to receive up to 10 yards free with proof of residency.

- Radiation Monitoring The PaDEP has promulgated new regulations requiring landfills to monitor vehicles for the presence of radioactive materials. As a result, on March 31<sup>st</sup>, 2003 the Authority started monitoring <u>ALL</u> vehicles for the presence of radioactive materials. **Please note:** you must enter the scales slowly or you may be required to turn around to re-enter.
