NEW Flat Rate For Self-Dumping Area

The WTL offers a self-dumping area for individuals to use for disposal of their household waste. By using this area our customers do not have to drive out into the landfill. The self-dumping area is open from 7:00 AM to 3:30 PM Monday thru Friday and 7:00 AM to 12:00 PM on Saturday.

When using the self-dumping area customers are charged a flat rate of \$18.00 for a pick-up truck or \$30.00 for a pick-up truck with a trailer. There is also a rate for 33 gallon bags of trash of \$3.50 per bag up to four (4) bags. Any vehicle with the capability of dumping must go to the garbage area and pay according to the weight of the load. Any vehicle arriving after the self-dump has been closed must also go to the garbage area and will be charged accordingly.

WTL Gets A New Face Lift

The Wayne Township Landfill has recently received a new face lift, including a logo change with new colors. With this also comes the announcement of a redesigned website. The website is expected to be activated by early June. The address for our website is www.waynetwplandfill.com.

40,000 Pounds of Electronics Recycled Since September 2004



Last September the Authority began accepting electronics at its Recycling Center in McElhattan free of charge. Since that time we have collected and recycled over 40,000 pounds of electronic products!

If you are asking yourself why you should recycle a computer or any other of the items listed above, the answer is because they may contain hazardous materials such as mercury, cadmium, or lead. Electronics make up 40% of all lead and 70% of heavy metals found in landfills. If electronic items are not disposed of properly these toxins can be released into the environment.

Electronics are considered to be any of the following items: televisions, computers and all accessories, printers, monitors, scanners, CD players, VCR's, stereo's, PDA's, telephones, answering machines, fax machines, camcorders and DVD players. **Microwave ovens can not be**

recycled through this program and must be disposed of in the landfill. The Recycling Center is accepting the above mentioned items on a daily basis, during regular business hours.

In an effort to remain environmentally friendly, it is the Authority's goal to keep these items out of the landfill. If you have questions about items that may be recycled please contact us at 570-769-6977. Thank you for recycling!





Message from the General Manager:

Spring has arrived and it is a very busy time for everyone. This also includes employees at the Wayne Township Landfill. We are cleaning up after the winter, and making preparations for grading, seeding and mulching to take place once the warmer weather comes around. This is also the time when we begin planning for the summer season and all of the services that we offer.

We are also planning for our 3rd Household Hazardous Waste Collection Day to be held in August. This gives the community a chance to get rid of hazardous materials that probably should not be disposed of in a landfill. A couple of things that people believe can't be handled regularly is used engine oil and paint. Used engine oil can be brought to the recycling center and reused as a heating fuel in our maintenance shops and our recycling processing building. The oil can be dropped off free of charge during normal business hours at the recycling center off of Tine Mountain Road. Faint should be left to sit with the lid off to dry or you can mix sawdust with it to make it solid. Once the paint has solidified it can be safely put into your regular trash for disposal.

A lot of work has been done by the Board of Directors and management to try to minimize the increase in monthly trash disposal for residents as well as industry. Through increases in services and efficiencies in operations we have lowered tonnage prices gradually since 1998. This has allowed your private haulers to maintain a low monthly bill, of which very few have seen any increase since the late 90's. We are all aware of increased costs in insurance, fuel and labor and we feel very proud that our efforts in lowering tipping fees has helped to save all of our customers money by helping the haulers keep a low monthly rate. Clinton County municipal waste actually comes into the landfill below what it actually costs. This is offset by the volumes of waste that come in from surrounding counties. One way of looking at it is that surrounding counties are paying for some of your monthly trash bill.

We recognize the strain on county residents from taxes and increased costs and try to do the best we can to have a positive impact on Clinton County and are always looking for ways to help with growth and development to make Clinton County a better place to live and work.

Household Hazardous Waste Collection Event August 12th and 13th

The Authority will be holding a Household Hazardous Waste (HHW) Collection event on Friday, August 12, from 2:00 PM to 6:00 PM, and Saturday, August 13, 9:00 AM to 2:00 PM, at the Authority's Recycling Center in McElhattan. All Clinton County residents are eligible to bring their HHW to the collection site. Due to regulatory requirements, business, commercial and industrial entities are not eligible.

Examples of items accepted include: ammonia-based cleaners, drain cleaners, oven cleaners, bleaches, garden chemicals, weed killers, insect spray, pool chemicals, pesticides, herbicides, paint, paint thinner, paint remover, art supplies, motor oil, anti-freeze, brake fluid, batteries, and any other products that are labeled: Caution, Warning, Danger, Poison, Toxic, Flammable, Combustible, Corrosive, etc.

Why You Shouldn't Burn



Open burning is dangerous to the public and harmful to the environment. Leaves and other yard wastes are light-weight and can easily lead to uncontrolled fires. A sudden gust of wind can carry embers and sparks quite a distance posing a substantial threat to

life and property. Communities throughout Pennsylvania are more frequently faced with banned burning due to dry conditions caused by frequent drought conditions. In addition, another problem with burning trash is the smoke that is emitted. The smoke contributes to atmospheric pollution and increases the risk of public health problems, such as asthma.

Backyard burn barrels are a major source of dioxin to the atmosphere. Dioxin is linked to increased risks of cancer, child development delays and damage to the immune system. Burn barrels also emit acid vapors and heavy metals, such as lead, cadmium and chromium, as well as unhealthy levels of carbon monoxide. The closer you are to a burn barrel, the higher the risk of inhaling dangerous pollutants.

The type of waste we generate is very different than it was years ago. In the past, waste mostly consisted of paper, wood and glass. Today our waste contains various types of plastics and other synthetic materials that create toxic emissions when burned. A backyard burn barrel can emit up to 7,000 times the toxic of emissions of a municipal waste incinerator due to incomplete combustion. Backyard burn barrels cannot reach sufficient temperatures to completely burn the waste and do not have emissions controls as required for commercial incinerators.

Please remember, by recycling materials such as newspaper, office paper, junk mail, magazines, corrugated cardboard, and plastics you can greatly reduce the waste generated by a typical household. This in turn will reduce your garbage bill and most importantly eliminate the dangerous pollutants associated with burning.

The Wayne Township Landfill would like to encourage all residents of Clinton County to recycle. We would also encourage residents to take advantage of our <u>free</u> brush and yard waste program. Just come into the office and sign in, then take your brush and yard waste to a specified location and then return to the office and sign out. It is very simple. No waiting in line. No charge.
