Electronic Recycling Program Update



The Covered Device Recycling Act (CDRA) of 2010 established a landfill ban for all electronic devices covered under the Act. The banned devices include: televisions, desktop and laptop computers, computer monitors, printers, and computer peripherals (e.g., keyboards, etc.). The landfill ban went into effect on January 24, 2013.

There were several flaws within the Act and ultimately it created an imbalance of supply and demand and made it economically prohibitive for electronic recycling vendors to operate within the State of Pennsylvania. This situation has been and is continuing to occur across the state and has resulted in several county and municipal programs discontinuing their electronic recycling efforts.

The Clinton County Solid Waste Authority currently provides an outlet for the residents of Clinton County to recycle electronic devices covered under the CDRA. This service is currently being provided at no cost to County residents, but due to rising operational costs and trickledown effect from imbalance of the supply and demand mentioned above, a fee may need to be imposed to make this recycling service sustainable.

The Authority is committed to provide waste disposal and recycling services to the region. This regional approach allows us to provide economical disposal and recycling options to the residents. An example of this commitment is the elimination of glass bottle recycling in 2016. This was done in order to improve the overall sustainability of our recycling program and with the intent that residents would still have an option for their glass bottles. Electronic recycling is a little more complicated due to the regulations created by the CDRA. As such, the Authority will continue to provide the residents of Clinton County with a recycling opportunity for their electronic devices, however the future may require a fee to recycle CDRA electronic devices, similar to the fees charged to dispose of waste and tires.

The Authority is working with several state organizations who are spearheading efforts to amend the CDRA. It is our understanding that legislation is being prepared and should be introduced in the near future. The legislation is anticipated to resolve the shortcomings of the CDRA and make electronic recycling sustainable throughout the Commonwealth.

Curbside Recycling Program



Below you will find a table that describes what we collect via our curbside recycling program. The table also outlines how to prepare the material for recycling and what materials are not accepted.

MATERIAL	WHAT CAN BE RECYCLED	HOW TO PREPARE FOR RECYCLING	WHAT CAN'T BE RECYCLED
Newspaper	Clean newspaper (including inserts).	Separate from mixed paper.	Wet or dirty newspaper.
Mixed Paper	Office paper, junk mail, phone books, magazines, catalogs, glossy paper.	Separate from newspaper.	Laminated paper and tissue paper.
Paperboard	Clean food boxes, paper towel rolls, shoe boxes, tissue boxes.	Include with mixed paper.	Wax coated food boxes, juice cartons, ice cream containers.
Cans	Aluminum & tin food and beverage cans.	Rinse, leave labels on.	Pie plates, aluminum foil, pesticide or herbicide spray cans.
Plastic Bottles & Jugs	Plastic bottles & jugs, coded #1 thru #7, less than 1 gallon in size.	Rinse, remove lids, leave labels on.	Containers greater than 1 gallon, toys, motor oil bottles, laundry baskets, chairs.

New Recycling Drop-Off Site At Gallagher Township Building

The CCSWA has opened a new recycling drop-off site at the Gallagher Township Building, located at 11837 Coudersport Pike. This site is open to all residents in the area and is accessible 24 hours a day. This recycling location accepts aluminum and tin cans, plastic bottles/jugs coded 1-7, newspaper, office paper, junk mail, catalogs, magazines and paperboard, as well as corrugated cardboard. Please separate your newspaper from the other types of recyclable paper.

Curbside Recycling Application

Have you considered the convenience of curbside recycling? The Authority will stop by your home every two (2) weeks and pick up your recyclables for a nominal **annual fee of \$42** (\$3.50 per month). The materials we collect include: aluminum & tin cans, newspaper, magazines, junk mail, paperboard and plastic containers (< 1 gallon in size). **(The Authority is under contract with the City of Lock Haven to provide this service to city residents. If you live in the City, please continue to put your recyclables out on your curbside on the regularly scheduled dates. If you need a collection bin, call City Hall at 570-893-5900.)**

Clinton County Residential Tire Collection Event



The Authority held another Tire Collection Event during the month of May. Ten neighboring municipalities from Lycoming County were also invited to participate. The event was very successful. Residents from 25 of 29 Clinton County municipalities participated with over 280 vehicles delivering tires. The event collected 4,473 tires, bringing the total number of tires collected since 2003 to over 76,000 tires!

 - ◆ Clinton County residents can bring Freon containing appliances to the Wayne Township Landfill free of charge.
 - ◆ Brush & Yard Waste can be brought to our mulch facility free of charge. Then on your way out purchase a load of landscape mulch. Natural Double Ground is \$22.00 per yard and the colored (brown, black and red) is \$28.00 per yard.
