#### Household Hazardous Waste Collection Event Scheduled for August 23 & 24

The Clinton County Solid Waste Authority will be holding a free two-day special event to collect Household Hazardous Waste (HHW) from Clinton County residents. Just bring your HHW to our Recycling Facility on Pine Mountain Road on August 23, from 8:00 am to 5:00 pm, & August 24, from 8:00 am to 1:00 pm. Due to regulatory requirements, this event is not open to commercial and industrial establishments.

Household Hazardous Waste is defined as any material containing ingredients that are corrosive, toxic, ignitable or reactive. Products such as insecticides, chemicals, cleaners and flammables contain potentially hazardous ingredients and require special care when you dispose of them.

Improper disposal of household hazardous waste can include pouring them down the drain, on the ground, into storm drains, or in some cases putting them out with the trash. The dangers of such disposal methods might not be immediately obvious, but improper disposal of these wastes can pollute the environment and pose a threat to human health.

## PA Adopts Slow Down to Get Around Law

Drivers who are distracted or going too fast are a major hazard for waste and recycling collection workers. Drivers are reminded to slow down and save lives of Pennsylvania workers while they are collecting waste and recycling materials along our roadways

In October of 2018, PA adopted a new law requiring motorists approaching and passing a stationary solid waste collection vehicle or a recycling collection vehicle to re-

duce and maintain a safe speed for weather, road conditions and traffic in order to proceed with due care and caution. Being struck by a motorist is a leading cause of death for waste and recycling collection employees, but with proper awareness it is completely preventable.

#### **Curbside Recycling Application**

Have you considered the convenience of curbside recycling? The Authority will stop by your home every two (2) weeks and pick up your recyclables for a nominal **annual fee of \$48** (\$4.00 per month). The materials we collect include: aluminum & tin cans, news-paper, magazines, junk mail, paperboard and plastic bottles & jugs (< 1 gallon in size). (The Authority is under contract with the City of Lock Haven to provide this service to city residents. If you live in the City, please continue to put your recyclables out on your curbside on the regularly scheduled dates. If you need a recycling bin, call City Hall at 570-893-5900.)

## **Clinton County Residential Tire Collection Event**



On May 17<sup>th</sup> and 18<sup>th</sup> the Authority held another Tire Collection Event. In addition to Clinton County residents, ten townships from Lycoming County were also invited to participate. The event was very successful. Over 500 residents participated from 26 of 29 County municipalities. The event collected over 5,300 tires, bringing the total number of tires collected since 2003 to nearly 86,000 tires! Thank you to everyone who helped to make this event a successful one.

## **Other Important News!!!**

- Clinton County residents may bring clean wood waste, brush & yard waste to our mulch facility free of charge. The charge for businesses is \$15.00 per ton for stumps, clean wood, and brush & yard waste. This material cannot be painted, stained, or treated.
- The cost for using WTL's **Self-Dump** is \$20 for a single load and \$33 for a double or oversize load. There is an extra charge for tires, out of county freon removal, and TV / computer component recycling.
- Clinton County residents with appliances containing Freon can bring them to WTL free of charge.

- Mulching season is here! Our #1 regular mulch is \$22 per yard. Want a little color in your yard? Choose dyed black or brown mulch for \$28 per yard.

#### **Curbside Recycling Notes**

Recycling should be placed at the curbside by 7:00 a.m., ready for pick-up on that day.

#### If your scheduled day of pick-up falls on a holiday, your recycling will be picked up on the next business day.

If you have more recycling than your curbside bin will hold, the overflow can be placed in bags as along as the material is sorted, for example, plastic bottles in one bag, mixed paper in another bag, etc.
